Strategic Plan/Back IN School Update

Superintendent of Schools Dr. Hertel and members of his Cabinet provided the Board of Education with an overview of the district's progress to date now that students have returned to school and a formal adaptive pause was set to begin on November 30. Student Performance Monitoring

Assistant Superintendent for Instructional Services Dr. Laura Sangroula, Assistant Superintendent for Student Services Dr. Ellen Swanson and Director for Second Language Learners' Programs Milagros Bravo provided an overview of District 62's student performance. The purpose of the student performance monitoring presentation is to provide the Board of Education with a review of District 62's performance in key areas. This year's <u>presentation</u> shows information pertaining to schooling during COVID-19.

The presentation will include information on the items bulleted below. Please note that the typical annual state required assessments (the Illinois Assessement of Readiness, the Illinois Science Assessment and the Dynamic Learning Maps alternate assessment) were not taken by students at the end of the 2019-2020 school year due to schools being abruptly moved into remote learning during the beginning of the COVID-19 pandemic. As such, the following information is included in this year's presentation:

- Academic performance: An early analysis of the impact of the COVID-19 disruption to schooling created by our partner analytics firm, ECRA.
- Tier 3 reading intervention: Information regarding our updated approach to servicing students who require intensive, tier 3 reading intervention.
- Social emotional support: Information regarding the social emotional toll on students and their families by the COVID-19 pandemic.
- ACCESS for English Learners: The results of last winter's ACCESS for English Learners English English language assessment.
- School designations on Illinois' ESSA accountability system
- Annual academic assessment outcomes as well as key action steps in response to these outcomes

Estimated Levy Resolution for 2020 Levy

The Board of Education adopted the 2020 tentative tax levy in the amount of \$78,443,000. This represents a 6.95% increase over the previous year. Taxpayers on existing properties will see an increase of approximately 2.3%, which is based on the Consumer Price Index. The 6.95% increase is intended to capture tax dollars from new construction. A public hearing will be held on December 14 prior to the Board voting on the final levy.

Board of Education

Vice President Morley discussed a Zoom meeting held with President Burton and members of the district union leadership to discuss thoughts and concerns for this school year as the district continues to navigate through this unique time of learning. President Burton extended his appreciation to those who were involved in the discussion and the dialogue. Board member Poskozim recognized that the Fair Tax amendment did not pass which will put stress on the state in terms of funding. Member Garrett visited Iroquois Community School and spent time speaking to staff. She also thanked and recognized Dr. Amadei and Dr. Swanson for their work managing the quarantines and contact tracing at the schools.

Superintendent Report

Superintendent Dr. Paul Hertel summarized student enrollment. Currently about 43% of students are in-person while the remaining are remote. An additional 150 students have requested to return to in-person learning beginning in January which will increase our numbers to 46% in person in January. Dr. Hertel also broke down the attendance by schools for in-person learners as noted in the chart below.
